

**UNITED WAY OF THE NATIONAL CAPITAL AREA'S SWEEPSTAKES
2018
OFFICIAL RULES**

NO PURCHASE, DONATION OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE, DONATION, OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. Void where prohibited by law and outside Maryland, Virginia, and the District of Columbia. Subject to all federal, state and local laws, regulations, and ordinances. Sweepstakes promotion begins on August 1, 2017 at 12:00:01 a.m. Eastern Time ("ET") and ends on March 31, 2018 at 5:00:01 p.m. ET on (the "Promotion Period"). Sponsor's computer is the official time keeping device for this Promotion.

1. Eligibility: United Way of the National Capital Area's ("United Way NCA") 2018 Sweepstakes (the "Promotion") is open to legal U.S. residents currently residing in the District of Columbia, Maryland, and Virginia who are at least eighteen (18) years old as of the date of entry. Entrants must have their principal residence or their principal place of employment in areas served by the United Way NCA's annual Community Campaign. Employees, officers, and directors of the United Way NCA ("Sponsor") or any of their respective parents, affiliates, subsidiaries, representatives, consultants, contractors, legal counsel, advertising, public relations, promotional, fulfillment, and marketing agencies, and members of their immediate families (spouses, parents, siblings and children, regardless of where they live) and those living in the same household are not eligible to enter or win. Participation constitutes entrant's full and unconditional agreement to these Official Rules and to Sponsor's and/or Administrator's decisions, which are final and binding in all matters related to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein. Sponsor reserves the right to verify the eligibility of winners.

3. How to Enter: During the Promotion Period, go to www.unitedwaynca.org to complete and submit the registration form, including a valid home address, name and email address. Those who accept the 2018 Sweepstakes rules will be automatically entered in one of three (3) ways to enter: A) New donors to United Way NCA who designate a minimum of \$1 per week (\$52 per year) will automatically be entered to win. B) Previous United Way NCA donors of \$52 or more per year, and who increase their gift by \$1 per week (\$52 per year) are automatically entered to win. C) You may also enter by sending a 3x5 card with your Name, Address and Phone Number and the words "Entry United Way NCA Sweepstakes 2018" to: United Way NCA Sweepstakes 2018, United Way of the National Capital Area, 1577 Spring Hill Rd., Suite 420, Vienna, VA 22182. P.O. Boxes are not permitted. You must provide all required information to be eligible to enter and win. All potential winners are subject to verification before any prize will be awarded.

Limit: LIMIT ONE (1) ENTRY PER PERSON, REGARDLESS OF ENTRY METHOD. ADDITIONAL ENTRIES WILL BE DISQUALIFIED. Automated or bulk entries or entries submitted by third parties will be disqualified. Entries must be submitted by the contestant. No copies, facsimiles, or mechanical reproductions of the Entry Form will be accepted. Any attempt

by any participant to obtain more than the stated number of plays and/or entries by using multiple and/or different identities, forms, registrations, email addresses, logins, or any other methods will void that participant's plays and/or entries, and that participant may be disqualified at Sponsor's discretion. Multiple participants are not permitted to share the same email address. In the event of a dispute as to any registration or play, the authorized account holder of the email address used to register will be deemed to be the registrant or player. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winners may be required to show proof of being the authorized account holder to the Sponsor or forfeit the prize. Entries specifying an invalid, non-working, or inactive email address will be disqualified and ineligible to win. You must complete all required information to be eligible to enter. Incomplete, illegible, corrupted, or untimely entries are void and will be disqualified. Selection of Winners: On or about April 16, 2018, Sponsor will select the name of the potential winner in a random drawing from among all entries received up until the end of the Promotion Period (March 31, 2018). The odds of winning are based on the number of eligible entries received. The potential winner will be notified by email and/or telephone, using the information provided at the time of entry, on or about April 16, 2018. Except where legally prohibited, the potential winner must sign and return, within ten (10) days of being notified, an Affidavit of Eligibility, Liability & Publicity Release or Declaration of Compliance and any other documents that may be required by Sponsor in order to claim his/her prize. If the potential winner cannot be contacted in person via email, telephone, and/or registered mail after the first attempt to contact him/her, or if he/she fails to sign and return the Affidavit of Eligibility, Liability & Publicity Release or Declaration of Compliance and any other documents that may be required by Sponsor within the required time period (if applicable), or if the potential winner and his/her companion are unavailable to travel within any time period specified by Sponsor, or in the event that the potential winner is disqualified for any reason, Sponsor will award the applicable prize to an alternate winner selected by a random drawing from among all remaining eligible entries. First Place Prize: One (1) First Place Prize will be awarded. The First Place Prize winner will receive one (1) Wegman's Gift Card valued at \$ 2,000 Second Place Prize: One (1) Second Place Prize will be awarded. The Second Place Prize Winner will receive One

(1) Wegman's Gift Card valued at \$1,000. Third Place Prize: Five (5) Third Place Prizes will be awarded. The Third Place Prize winners will each receive one (1) Visa Gift Card valued at \$500. Fourth Place Prize: Five (5) Fourth Place Prizes will be awarded. The Fourth Place Prize winners will each receive one (1) Visa Gift Card valued at \$150 .

6. Prize Restrictions: Grand Prize winner is solely responsible for **any and all** expenses in connection with the Grand Prize not expressly described herein as being awarded including, without limitation, the following: (i) all income, federal, state or local taxes; (ii) insurance, registration fees, any travel/shipping costs associated with transporting vehicles from dealer to winner's destination, dealer preparation fees and/or additional options, additions or equipment; and (iii) any tags, taxes and title fees; (iv) any additional expenses not described herein as being awarded. Grand Prize winner must have a valid driver's license issued in their state of residence and/or country and proof of insurance to take delivery.
