## **LETTER FROM THE CEO**



It's hard to believe we are still navigating the COVID-19 global pandemic as well as the impact and outcomes of this crisis. One thing we know for certain, is that the need for an equitable recovery is even greater than before. At your United Way, we are committed to fighting for every single one of our neighbors to have access to the health, education and economic opportunity they need—especially as we look ahead post-pandemic and beyond.

Your United Way of the National Capital Area has always been centered around providing the tools, resources and capacity for individuals and families in our community to thrive, even during difficult times. As you can imagine, many in our region have been completely devastated by the pandemic, and the long-existing systems of inequity have only been made worse. We've seen exponentially higher levels of food and housing insecurity as well as unemployment and education gaps. As we continue to navigate these challenges, where we go from here will be determined by how we ensure everyone has the access they need to thrive in a post-pandemic world.

Last year, a fifth location was added to United Way NCA's regional network of Financial Empowerment Centers (FECs). Together with M&T Bank and Coalition for the Advancement of Financial Education (CAFE Montgomery), we opened a new United Way NCA Financial Empowerment Center (FEC) at Montgomery County. All FEC locations in our region continued to operate virtually, providing free financial counseling and coaching to help residents navigate furloughs, layoffs or reductions in income.

We also launched a comprehensive program to reduce COVID-19 infection and death rates in Black and Brown communities in the National Capital Area. The program began with United Way NCA's participation in the Choose Healthy Life Black Clergy Action Plan (CHL)-a historic multicity initiative that aims to raise awareness and educate the Black community on COVID-19 and other health disparities; develop infrastructure and advocacy; and, most importantly, provide access to COVID-19 testing for high-risk communities through the Black church, the oldest and most trusted institution in the Black community. We convened Quest Diagnostics, CareFirst BlueCross BlueShield (CareFirst) and Deloitte, all of whom made significant investments for the distribution of COVID-19 testing and vaccinations throughout the region while removing barriers by providing free transportation and education. With these new investments, the program has expanded into a region-wide effort to ensure equitable access to COVID-19 resources.

Your United Way also brought together local partners to provide much-needed resources to those at risk of or experiencing homelessness, as well as our Asset Limited, Income Constrained, Employed (ALICE) population. ALICE represents the growing number

of individuals and families who are working but are unable to afford the basic necessities. A total of 5,200 essential kits were distributed during the week of our annual Project Community Connect (PCC) across D.C., Maryland and Virginia. The kits distributed included healthy snacks, hygiene products and warm clothing items. While it may sound simple, these kits are strongly connected to the overall health, education and economic opportunity of residents throughout the National Capital Area.

As we continue to seek ways to provide our community with the support they need, there is one thing that has remained clear: this work requires equity at the center of it, and it requires all of us. At your United Way, we believe in strength in numbers and bringing to the table the expertise, thought leadership and resources to organize around the most pressing issues of the moment. This work cannot be done alone because there is no one simple solution to each issue. However, what we believe to be true at United Way NCA is we need to Live United in the equity movement to create a better future—one where communities have their basic needs met and we are bridging the divides in our economy and education systems.

While there is much that has been done in the last year, this is only the beginning. I believe that the work that lies ahead will be the most significant and transformational in our lifetime. We invite you to join us on this journey building an equitable recovery and future for all.

When none are ignored, all will thrive.

# UNITED WAY NCA LAUNCHES COMPREHENSIVE PROGRAM TO REDUCE COVID-19 INFECTION AND DEATH RATES IN BLACK AND BROWN COMMUNITIES IN THE DC AREA


In response to the pandemic, United Way of the National Capital Area (United Way NCA) launched a comprehensive expansion program to reduce the number of COVID-19 cases and death rates affecting Black and Brown communities throughout the DC area. United Way NCA partnered with Quest Diagnostics, CareFirst BlueCross BlueShield (CareFirst) and Deloitte, all of whom made significant investments for equitable access to and the distribution of COVID-19 testing and vaccinations throughout the region while removing barriers by providing free transportation and education.

This program uses a four-pronged approach to reduce COVID-19 cases in Black and Brown communities, including testing, vaccinations, free transportation, and education and awareness. It began with United Way NCA's participation in the Choose Healthy Life Black Clergy Action Plan (CHL)—a historic multi-city initiative that aims to raise awareness and educate the Black community on COVID-19 and other health disparities, develop infrastructure and advocacy and, most importantly, provide access to COVID-19 testing for high-risk communities through the Black church, the oldest and most trusted institution in the Black community. Ultimately, the goal of United Way NCA's expansion program ensures no one is left behind when it comes to education and access.

Starting in February 2021 with an initial investment from Quest Diagnostics and the Quest Diagnostics Foundation, United Way NCA identify and partnered with 10 Black churches in Maryland and DC to support uninsured or underinsured African Americans through community mobilization. Each church is staffed with a Public Health Navigator and led by a Health Navigator Supervisor from Mary's Center here in DC.


Additionally, CareFirst, as part of its "Better Together Campaign," joined United Way NCA's effort to increase the availability of vaccinations throughout the Washington, DC, Maryland and Northern Virginia regions. CareFirst's long-term goal is to combat other chronic diseases, such as diabetes and hypertension, facing communities impacted by racial inequities and build on United Way NCA's current program to close the equity gap in health care beyond COVID-19.

Deloitte's investment provides capacity to expand vaccinations beyond the 10 churches to cover more of the region, amplify education and awareness and eliminate access barriers by providing free rides through United Way's Ride United program for those in need of transportation to testing and vaccination sites

# HOW EXPOSURE TO STEM EDUCATION CHANGED PRINCE GEORGE'S COUNTY STUDENTS' VIEWPOINTS ON TECHNOLOGY



United Way NCA is focused on the education pipeline from middle school to college and/or career success. We work in Title I schools in our area, addressing attendance, behavior, and course performance through our Community Schools program. As part of these efforts, our focus on the middle school to college/career pipeline puts our Asset Limited, Income Constrained, Employed (ALICE) students and their families front and center. ALICE represents the growing number of individuals and families who are working but are unable to afford necessities. Working side-by-side with our partners, we prepare students in targeted, at-risk middle schools to transition successfully to high school and perform at grade level.

When it comes to preparing students to succeed, it's never too early to begin thinking of what one wants to do with their future. United Way NCA knows the data points to middle school as the beginning of the pipeline for students to succeed in college and/or their careers. Early exposure to different fields of work can make all the difference in inspiring students to think about their futures and set goals for themselves.

That's why United Way NCA teamed up with Deloitte's Al Institute for Government to offer a 12-week virtual STEM (Science, Technology, Engineering and Math), one-hour, after-school program for 40 students across eight Title I middle schools that are part of Prince George's County Public Schools Community Schools. The program began in February 2021 and wrapped up in May 2021, just before the start of summer break.

# HELPING REDUCE ECONOMIC DISPARITIES DURING TAX SEASON

For many across the country, tax season is a flurry of confusion and anxiety. Taxes can be riddled with complexities, and a heavy lift for many residents in the National Capital Area causing many low wage workers to choose not to file taxes at all. The result is that year after year families lose thousands of dollars in unclaimed benefits. However, in a year unlike any other, where we witnessed many individuals unemployed or underemployed, a sizeable tax return can go a long way in resolving debt, feeding the family or replenishing savings for the remainder of the pandemic.

But accessibility and tax filing do not always go hand in hand. Some tax processors charge hundreds of dollars for a return that takes minutes to file. To maximize the number of families in our region saving money during tax season, United Way NCA convenes its powerful regional network of five Financial Empowerment Centers and over XX Volunteer Income Tax Assistance partners to provide our community with free tax preparation services and guidance on tax credit options at no cost.

Through the VITA program, IRS-certified VITA tax volunteers help qualified community members understand and qualify for the Earned Income Tax Credit (EITC). EITC has been called the most effective U.S. anti-poverty program and is even more important for low-wage workers across the region as they navigate the pandemic. Tax refunds, as a result of the EITC, have

proven instrumental in lifting people out of poverty, going so far as empowering them to put their children through school, get ahead on rent payments, or even become homeowners.

"It is important that we are helping everyone in our community get the most back when they file. Credits like the Earned Income Tax Credit (EITC) can help individuals and families get back thousands of dollars every year—enough money to lift them out of poverty. And without the support of the United Way of the National Capital Area's VITA locations, we would not be able to reach as many people as we do."






